Why a website?

- Timeliness of information: instead of waiting for a periodic newsletter, news and events can be posted anytime.

- Easy access to information and documents: remember the list of service providers sent out a number of months ago? On the website! Want to check something in the Covenants or Architectural Guidelines? On the website! Need a neighbors' email address? On the website (password protected)! Need to contact a committee or board member? On the website!

Check it out - just type in <u>http://www.eastshoressc.com/</u> to get to the home page. After looking at the News and Events section you can "click here" from the top or bottom of the page to access links to other sections.

### KEY THINGS TO KNOW:

a) The East Shores Directory is password protected. You will receive a separate email in the next couple of days with the password.

b) Beginning January 2014 the **clubhouse calendar will be maintained on the website.** This will enable users of the clubhouse to schedule events from home. Access to the calendar requires a user name and password. These will also be sent in the same email as the directory password.

c) You can have news and information posted on the website. Or you may have a suggestion to improve the site. Use the link at the bottom, right of the website page to contact the webmaster, Mark Torres.

### From the Owners Association

<u>Car Break-in Update:</u> The car break-ins that occurred October 20th are still under investigation. The police have asked that if anyone has future problems of any sort for **each individual family/incident report to the police**. It helps them to have separate reports filed for each individual incident, no matter how minor it may seem.

In addition to the car break-ins update, Kevin Christenbury reported that on the night of Friday, November 8, about 3:15 a.m. he was up with the baby and heard a car outside and saw a car at the end of his driveway. He turned on lights and by the time he got outside they were pulling away The car shape looked like a Prius. He turned on all outside lights for the remainder of the night. Please be extra vigilant of unusual occurrences. A discussion our recent ESOA board meeting was to install motion sensor outdoor lights to your home for added security.

One of our residents is also aware that several neighborhoods in Clemson (around Berkeley Drive) have been burglarized recently. Shortly before the robberies took place a woman was seen knocking on doors in the targeted neighborhood pretending to be lost and needing directions. When no one came to the door, the house was broken into. We remind all East Shores residents that door to door solicitations are prohibited and if any of us see anyone acting in a suspicious manner, we should report it to the police and warn neighbors to be careful and on the look-out.

Covenants and By-Laws: Mentioned in the April newsletter was the work done by Paul Benson, Rick Clarke and Walter Dahl on updating our East Shores Covenants and By-Laws. The board has reviewed these recommendations and will be meeting with the above three in early 2014 to prepare to bring the changes to property owners for a vote. In addition, the scope of changes has increased and we will be removing all references to Crescent Resources. Inc. Preliminary legal review has occurred and Karl Meurlot, an East Shores property owner, has offered to take a "lawyers eye" look at the final proposed document. All documents related to our Covenants, By-Laws and Architectural Guidelines have been converted from an uneditable paper document to an electronic format that can be modified. There was an erosion problem along the right side as you approached the dock caused by the heavy rains this year. River rock was added to address the problem. Many residents have used this path through the summer with very positive feedback.

Watch your speed-Please remember that the speed limit for our community is 25 MPH and be especially mindful of your speed as you travel through the community. With the cooler weather, neighbors will be more bundled up when out and about and may not hear approaching cars as readily. And with less daylight it can be tougher to see people out and about. All good reasons to take it slow (and easy). Thank you in advance for your attention to the safety of everyone who lives in East Shores.
